Grant for 2018 home purchases increased to \$13,000

For beneficiaries purchasing their first home, the grant will be 50% of out of pocket expenses (earnest money, closing costs, down payment, not including any seller credits) up to \$13,000.

For beneficiaries who have previously owned a home, the grant will be 4% of the purchase price (up to \$13,000) provided that the beneficiary has paid at least that amount at closing – otherwise the maximum they have paid in to closing.

All monies granted will be distributed after the home purchase is closed.



IMPORTANT!! All beneficiaries, 18 years of age or older, must now complete an Email consent form and return it to their family representative. This consent form will allow the Opportunity Fund to communicate with all beneficiaries by Email. It will also allow your email address to serve as your electronic signature for approvals and other actions you make in conjunction with the Baughman-Marinelli Opportunity Fund. Please return your Email consent form to your family representative no later than May 15th.
